AMENDMENT OF CERTIFICATION

Pursuant to Section 2422.1 of the Regulations of the Federal Labor Relations Authority, a petition was filed seeking to amend the certification granted to the American Federation of Government Employees, Local 2486, AFL-CIO (AFGE), in Case No. 22-2304(RO), as the exclusive representative of certain employees of the Department of Health and Human Services, Food and Drug Administration, Baltimore District, by changing the designation of the exclusive representative for the existing bargaining unit, from AFGE to the National Treasury Employees Union(NTEU).

On July 2, 1999, I issued a Decision and Order finding that the certification may be amended as requested.

The parties waived their right to file an Application for Review. Pursuant to the authority vested in me as Regional Director,


I ORDER that certification granted to AFGE, on April 12, 1971, in Case No. 22-2304 (RO), as the exclusive representative of the following unit of employees:

All professional and nonprofessional wage board and general schedule employees of the Food and Drug Administration, Baltimore District; but excluding all management officials, supervisors, guards, and employees described in 5

U.S.C. 7112 (b), (2),(3),(4),(6) and (7).

is amended by changing the exclusive representative from AFGE to the National Treasury Employees Union.
