2001 Vote for Consolidation of Professional and non Professional Units in NTEU Chapter 282:

Result: FDA professionals (those required to have completed an advanced course of study as a mandatory requirement for their job, i.e., scientists, medical professionals, CSOs, etc.) voted 673 to 341 for inclusion in a single FDA consolidated unit (non Professional employees did not vote).

Ballots mailed by FLRA to all (3,500 NTEU member and nonmember) FDA professional bargaining unit employees on November 2, 2001; ballots were due by December 9, 2001 and counted on December 10, 2001.
